

MINUTES OF MEETING

Minutes of the Annual General Body Meeting of Sqay Federation of India, held on 22nd June 2022 at 11:00 am at Pahalgam Club, Pahalgam, J&k. Following members from States/UT's were present (list enclosed) :-

The Annual General Body Meeting was conveyed as per the schedule under the chairmanship of Mr. Nazir Ahmad Mir, Former Secretary General – Sqay Federation of India at Pahalgam Club J&K and he gave warm Welcome address among the members who have come from 24 States/ UT's from across the country and thanks all of them for their active participation and love towards the Sqay Martial arts . The former Secretary General of Sqay Federation of India gave detailed briefing about his work and then handed over the chair to Returning Officer to conduct the election of federation. The election was conducted in free and fair atmosphere and according to the National Sports Code 2011 and under the guidelines of Ministry of Youth Affairs and sports Government of India. After the election, the chair was handed over to newly elected President Mr. Basharat Rasool to continue the proceedings of the meeting with the permission of the Chair and during the minutes of meeting the following points were discussed which are given as under :-

1. Discussion about the upcoming EBSB events across the country:-

The newly elected President informed that Sqay is now a medal Sport in the EBSB calendar and congratulated the house led by Executive Board and Members of different states & UTs for their hardwork and love for the sport and advice all the members to work for the upcoming EBSB events with a huge participation to make this mission a Grand success. He informed the house that now almost Sqay is played in all nooks and corners in the country and EBSB also helps our sport to reach in every village and we should be thankful to all the officers of EBSB and ministry of sports for supporting and encouraging us to reach us to every village through EBSB platform. The EBSB championship will be conducted after the confirmation from EBSB Secretariat.

2. Online Registration System of Athlete's Process:-

It was informed that as per the Ministry of sports- GOI guidelines, online registration of players is compulsory for every sport. So we also have to follow up the procedure, so all the states should come up with a data for online registration system, which will be made available on our official website soon, It was decided that now all the circulars ,meeting notices participation/results of the events will be uploaded on the official website of the federation for better transparency.The house agreed upon the said Decision passed with majority.

3. Discussion about the Selection for South Asian and Asian Championship 2022.

It was decided that the Indian Sqay Team will be deputed for the forthcoming South Asian Sqay championships 2022-23 scheduled to be held in Nepal. So all the states will be informed well before the schedule and will be provided a list of the athletes who will be called for National Camp as well. Moreover the selections for Asian championship will be conducted accordingly after receiving dates from the organizers. The house appreciated the decision.

4. Starting of SQAY Pro-League for the promotion of Sqay :-

The chair suggested that SQAY Pro-League should be introduced for the promotion and development of Sqay within country. It was decided that all state/UT heads will find sponsors for the Sqay Pro-League. The final decision about team selection will be taken after finding the suitable sponsors. The house lauded the decision and agreed to follow up for the necessary action on the same decision at an earliest.

5. Allotment of 23rd National Sqay Championship :-

The General Secretary of J&K Sqay Association with the permission of chair showed interest in hosting the 23rd National Sqay championship and it was decided by the house that the 23rd National Sqay championship will be allotted to J&K Sqay Association in all age groups. The championship will be held at Jammu Division and the dates ,venue and accommodation details will be provided later by the concerned Association. The house applauded the chair and gave full support on the decision taken by the house.

6. Discussion about the conduct of Domestic Activities in every State from District level to State Level and conduct of regular seminars for the upliftment of SQAY (Martial Arts).

The house decided that every State and UT should make the Domestic Level activities compulsory in every District and for the better promotion of the sport, we should encourage the club system, which will help us to reach the sport to every athlete. It was decided that the old affiliated units will activate all their respective districts and new units will work hard and try to develop sqay atleast minimum in 50 to 80% of their districts. The house agreed and assured that the same idea and orders will be abided accordingly.

7. Conducting National Interstate and Zonal Championships:

The House suggested that National Interstate and Zonal Championships should be conducted regularly so that players will continuously remain in touch with the game. The North Zone SQAY Championship was allotted to Haryana and other states were advised to provide necessary dates and venue for hosting other zones (Eastern, southern and western).

The meeting was ended with the vote of the thanks by the Chair.
