<u>Championship scheduled to be held at Rohru, H.P from 20th to 23rd August 2019-Regarding.</u>

Sir,

This is with reference to your letter no. 707-14/SFI/19 dated 29.06.2019 regarding subject cited above.

I am directed to say that Competent Authority, has agreed in principle for the sanction of grant not exceeding Rs.5,00,000/- (Rupees Five Lakhs Only) to the Secretary General, Sqay Federation of India for conducting above-mentioned Championship. **This grant is of non-recurring nature.** As per terms and conditions of MYA&S's letter No.9-3/2013-SP.I dated 1st March 2017, out of the above grant reimbursement of an amount up to 90% or actual expenditure whichever is less will be made on account of expenditure towards boarding, lodging and transportation (in **Rohru**) of "Sportspersons" For this purpose "Sportspersons" will include Coach, Manager, Referee, Doctor and Masseur accompanying the team, In addition to above 90% amount, Government will also reimburse amount up to (10% of the approved amount) for actual rent of play fields and cost of consumable equipment including certificates and medals.

- 1. The grant is subject to the conditions mentioned below:-
 - I. That at least 75% of the total affiliated units will take part in the Championship. In case percentage of participation is between 50 and 74.9 Government grant will be reduced by 25%. However, no grant will be payable for participation below 50%.
 - II. That the grantee shall execute a bond with two sureties to the President of India for acceptance of terms and conditions of the payment of Grant-in-aid before release of the payment.
 - III. The grantee shall maintain subsidiary accounts of the grants-in-aid received from the Government.
 - IV. The grantee shall maintain a register of assets in the prescribed form GFR 19. The assets acquired wholly or substantially out of government grant except those declared as obsolete and unserviceable or condemned as per the procedure laid down in the General Financial Rules shall not be disposed of without the prior approval of the Ministry of Youth Affairs & Sports.
 - V. The amount so paid to the grantee shall be open to inspection by the Sports Authority of India whenever the grantee is called upon to do so.*
 - VI. The account shall be audited by the Internal Auditors of grantee and finally be the Comptroller and Auditor General of India under Section 14 of the CAG of India (Duties, Power and conditions of Service) Act, 1971.
 - VII. The grantee shall not divert the grants and entrust execution of the scheme or work concerned to the institution or organization and shall abide by the terms and conditions of the grant. If the grantee fails to utilize the grant, for the purpose for which the same has been sanctioned, the grantee will be required to refund the entire amount with interest thereon @ 10% per annum. As per Rule 209(6) (ix).

- The UC should also disclose whether the specified, quantified and qualitative target that should have been reached against the amount utilized were in fact reached, and if not, the reasons therefore As per Rule 212 (1).
- The accounts of all grantee institutions or organizations shall be open to inspection by the sanctioning IX. authority and audit, both by Comptroller and Auditor General of India under the provision of CAG (DPC) Act, 1971 and internal audit by the Principal Accounts Office of the Ministry of department, whenever the institution or organization is called upon to do so and a provision to this effect should invariably be incorporated in all orders sanctioning grants-in-aid. As per Rule 211 (1).

X. The grantee shall submit the utilization certificate in prescribed form GFR 19 A, received for the purpose duly signed by the General Secretary/President within 12 months after closure of financial

year as per Rule 212 (1) of GFR.

XI. The grantee agrees to make reservation for Scheduled castes and Scheduled tribes in posts/services under its control on the lines indicated by the Government of India.

- XII. That the grant is adjustable on the basis of the actual expenditure. For this purpose a statement indicating the list of participants (state-wise) and a audited statement of income and expenditure (duly audited by a Chartered Accountant) in the manner as mentioned in Para 2 above may be sent to this Ministry.
- XIII. That a performance cum achievement report (2 copies) in respect of the above event for which that grant has been sanctioned should be forwarded to Regional Director (TEAMS (within 01 month of the event);
- That no advertisement of tobacco and liquor will be displayed during the event, the breach of XIV. which entails the cancellation of government grant.
- XV. That in case of Senior Championship, the Federation will have to conduct the Junior and Sub-Junior Championships in the same financial year. In case these are not conducted, the grant released for the Senior Championship will be recovered from the Federation.
- That it should be compulsory for the Federation to hold state level tournaments in all states for XVI. both men and women.
- As far as district tournaments are concerned, it should be held in at least 50% district for Men & Women before the Federation becomes eligible for release of remaining grants and fresh
- XVIII. The grant in aid is further subject to the conditions laid down in GFRs as amended from time to time.
- Reference to the Ministry's letter No. F.8-06/2011-SP.III, Government Of India, Ministry of Youth Affairs & Sports (Department Of Sports), Shastri Bhawan, New Delhi-01 dated: 23rd February, 2011, now the proposals for holding National Championships, International tournaments in India and visit of Indian Sportspersons/Teams Abroad, as per their approved Annual calendar for Training and Competition (ACTC), received from the NSFs will be processed by the Sports Authority Of India, TEAMS Division, Office Order from Ministry.

As per office order no. No.12-5/2013-SP.III dated 4th November, 2015 under the provision of the Scheme of Assistance to National Sports Federations (NSFs), Financial Assistance to the NSFs Scheme has been reviewed by the Ministry, accordingly "level of funding for Sub Junior in 'Priority' and 'General' Categories and for Seniors and Juniors in all Categories shall be at the same uniform level as applicable to Seniors.

The amount of the grant will be debit-able to the head, under the provision of the Scheme of Financial Assistance to National *Regional* Sports Federations (NSFs).
